The authorization under rule 10 of the Bio- Medical Waste Management Rules, 2016 is hereby renewed for period from **17/01/2022 to 16/01/2025** subject to the fulfillment of terms & conditions incorporated in the authorization letter no. **1866/BMW/HO/CECB/2005/Raipur, dated 17/01/2005** and additional conditions are enclosed herewith.

CONDITIONS PERTAINING TO THE BIO- MEDICAL WASTE MANAGEMENT **RULES, 2016**

Form III **(See rule 10)**

[Authorization for operating a facility for generation, collection, reception, treatment, storage, transport and disposal of bio-medical wastes]

1. Number of authorization **1060/HO/BMW/CECB/ATAL NAGAR, RAIPUR.**
2. Reference of Online Application No. **8995877 dated 16/01/2022** Subsequent correspondence ending dated 05/05/2022.
3. The authorization granted vide letter no. **1866/BMW/HO/CECB/2005/Raipur, dated 17/01/2005** to occupier of facility i.e. **Balco Hospital (100 Beds), Balco Nagar, Korba, Distt.- Korba (C.G.)** is hereby granted an authorization to operate a facility for collection, reception, storage, transport, treatment and disposal of Bio-Medical Wastes as per the agreement with **M/s Envirocare International (Chhattisgarh), LIG-137, R.P. Nagar, Phase-II, Korba, Distt.-Korba** for disposal of BMW which has been granted authorization by **C.E.C.B. Raipur (C.G.)**
4. This renewal of authorization shall be in force for period from **17/01/2022 to 16/01/2025.**
5. This renewal of authorization is subject to the conditions stated below and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act 1986.

TERMS & CONDITIONS OF AUTHORIZATION

1. The authorization shall comply with the provisions of Environment (Protection) Act, 1986 and the rules made there-under.
2. The occupier shall obtain membership from CBWTFs for Bar Coding and final disposal of their Bio Medical Waste.
3. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the prescribed authority.
4. The person authorized shall not rent, lend, sell transfer or otherwise transport the Bio-Medical wastes without obtaining prior permission of the prescribed authority.
5. Any unauthorized change in personnel, equipment, or working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
6. It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
7. The occupier shall submit in annual report in enclosed form-IV by 30th June every year to concern Regional Office of the Board.
8. No untreated Bio-Medical waste & shall be kept stored beyond a period of 48 hours. Provided that if for any reason it becomes necessary to store the waste beyond such period, the authorized person must take permission of prescribed authority and take measures to ensure that the waste does not adversely affect human health and the environment.
9. The occupier shall take necessary action for the treatment of effluent generated from the hospital so as to meet the standards prescribed under Water (Prevention and Control of Pollution) Act, 1974. Standard limit is given below :-

pH	:	6.5-9.0
Suspended solid	:	100 mg/l
Oil and grease	:	10 mg/l
BOD	:	30 mg/l
COD	:	250 mg/l
Bio-Assay Test	:	90% survival of fish after 96 hours in 100% effluent
