1.0 Introduction

- 1.1 Bharat Aluminium Company Limited (hereinafter referred as "BALCO") a subsidiary of Vedanta Resources PLC, is one of the world's leading diversified natural resources companies with business operations in India, South Africa, Namibia, and Australia. Vedanta is a leading producer of Oil & Gas, Zinc, Lead, Silver, Copper, Iron Ore, Aluminium, Steel and commercial Power.
- 1.2 The company operates a state-of-the-art Aluminium smelter having an installed capacity of 0.56 MTPA and an integrated 2010 MW Thermal Power generation facility at Korba, Chhattisgarh.

The objective of this EOI is to solicit proposals from the interested bidders for participation in a bid process for selection of prospective buyers (Business Partners) for Sale of Ash for the capacity equivalent to 600 MW of the total installed capacity of 2010 MW of the coal-based Thermal Power Plant at Korba, Chhattisgarh. Thus, to increase ash utilisation and realisation of realisable value of the commodity like ash, BALCO is hereby inviting Expression of Interest (EOI) from prospective Business Partners (Buyers).

The Ash will be Sold / Offered to the Prospective Buyers through competitive bidding process.

1.3 **Basic information:**

- 1.3.1 Plant capacity: 2x300 MW.
- 1.3.2 Total ash disposal: 1.4 MTPA (IPP units)
- 1.3.3 The plant is situated at Korba, Chhattisgarh.

Location: Balco Nagar, Korba (495684).

Nearest Railway Station: Korba.

2.0 Expression of Interest:

BALCO invites "Expression of Interest (EOI)" from interested Buyers for "Sustainable Utilization of Ash generated from Independent Power Plant of BALCO, to be lifted from ash dyke as well as from dry ash Silo & Dewatering Bin". The work is to be carried out on 'as is where is' basis. The utilization, consumption and export of ash to other locations inside India shall be carried out in

an environment friendly and sustainable manner in compliance with the prevailing guidelines of Ministry of Power (MoP), Ministry of Environment, Forest and Climate Change (MoEF&CC), Chhattisgarh Environment Conservation Board (CECB) and other Statutory Authorities". Interested Buyer(s) are requested to clearly indicate the inputs required from BALCO.

3.0 Purpose of this EOI:

Through this EOI, BALCO intends to provide the ash generated from its Thermal Power Unit at a reasonable cost to the interested and capable Buyers for utilization and consumption in an environment friendly manner as per guidelines issued by MoP, MoEF&CC, CECB and other Statutory Authorities

The Interested buyers shortlisted on the basis of their "Expression of Interest (EOI)" will be considered for the competitive bidding, subsequent to which selective buyers shall be finalized for supply of ash at a reasonable price from BALCO on 'as is where is' basis.

4.0 Role of the Interested Buyer(s) and BALCO

- 4.1 In order to promote utilization of ash as resource material; and to encourage the ash utilization of BALCO, Korba, Chhattisgarh. BALCO invites potential bulk Buyers for the purchase of ash at a reasonable cost for utilization in ecofriendly manner in accordance with the guidelines, notifications and directions issued by MOP, MoEF&CC, CECB and other Statutory Authorities from time to time.
- 4.2 Prospective Buyers may submit their offer for purchase and further lifting of ash from the plant silo, Dewatering Bin, ash pond or ash from all these sources. The offers should include the particulars of the company along with the background of operation, business where the ash will be utilized, tentative plan, proposed quantity of ash to be utilized, etc. in accordance with the notifications and guidelines issued by MoP, MoEF&CC, CECB and other Statutory Authorities from time to time.
- 4.3 Interested buyers shall sign a long-term agreement with BALCO for utilization of Ash as per their requirement at their risk and cost in an environment friendly manner by complying with all the applicable notifications and guidelines issued from MOP, MoEF & CC, CECB and other Statutory Authorities in relation to transportation and utilization of ash.

- 4.4 All the costs for transportation and utilization of ash, necessary regulatory permissions, taxes, duties, etc. as may be applicable shall be borne by the prospective Buyer(s).
- 4.5 Loading of dry ash will be made available by BALCO on 'as is where is basis' from the silo inside the plant of BALCO, Korba, Chhattisgarh.
- 4.6 Similarly, pond ash in dry form will be made available by BALCO at a reasonable cost on 'as is where is basis' at the ash pond. Interested Buyer(s) will have to make arrangements for loading and transportation of ash from ash pond.
- 4.7 Mode of packing, loading, transportation, and utilization must be clearly mentioned by the interested Buyer(s).
- **4.8** Interested Buyer(s) may clearly indicate the inputs required from BALCO.
- 4.9 All the works of ash packing, loading, and transportation must be executed in conformity with the EHS (Environment Health and Safety) & VSAP (Vedanta Sustainability Assurance Program) rules and regulations of Vedanta.

5.0 Required Information:

- 5.1 The prospective Buyer(s) shall submit the particulars of their firm with the complete background of their operations, businesses (including financial statements) along with the details of avenues where the ash will be utilized, tentative plan, and the proposed quantity.
- 5.2 The Buyer(s) submitting the EOI shall be bearing all costs associated with the preparation and submission of the EOI and BALCO shall in no case or manner be responsible or liable for these costs, regardless of the conduct or outcome of the assessment & evaluation process.
