1.0 Introduction

1.1 Bharat Aluminum Company Limited, (here in after referred as "BALCO") a subsidiary of Vedanta Resources PLC, is one of the world's leading diversified natural resources companies with business operations in India, South Africa, Namibia, and Australia. Vedanta is a leading producer of Oil & Gas, Zinc, Lead, Silver, Copper, Iron Ore, Aluminum, Steel, and commercial Power.

The company operates a state-of-the-art aluminum smelter having an installed capacity of 0.56 MTPA and an integrated 2010 MW thermal power generation facility, at BALCO, in Chhattisgarh.

2.0 Expression of Interest:

BALCO invites "Expression of Interest (EOI)" from interested user agencies for purchase of ash through e auction process. Qualified Buyers shall be allowed for "**Off taking of ash including dry fly ash, bottom ash and pond ash";** at Vedanta Limited, Thermal Power Plant in Korba, for utilization in environment friendly manner as per the prevailing guidelines of MoEF & CC and SPCB".

3.0 Purpose of this EOI:

Through this EOI, BALCO intends to provide the Ash generated from its Thermal Power Unit at a reasonable cost to the interested and capable Buyers for utilization and consumption in an environment friendly manner as per guidelines issued by MoP,

MoEF&CC, CECB and other Statutory Authorities

The Interested buyers shall be shortlisted for participation in e auction after scrutiny of their credentials provided by this "**Expression of Interest**". All the Shortlisted **buyers** shall be intimated for deposit of EMD amount along with requisite details for participation in the open auction process.

4.0 Role of the Interested Buyers & VL

- **4.1** To promote utilization of ash as resource material; and to encourage users/buyers for utilization of ash (Dry Fly ash, bottom ash, and pond ash) of BALCO, Korba, Chhattisgarh; BALCO invites potential buyers for supply and consumption of ash in eco-friendly manner as per prevailing guidelines of MoEF & CC and SPCB.
- **4.2** Eligible buyers shall submit their offers for lifting ash (Dry Fly ash, bottom ash, and pond ash). The offers should include the particulars of company with the background of operation, business where ash will be utilized, etc in accordance with the notifications and guidelines issued by MoP, MoEF&CC, CECB and other Statutory Authorities from time to time.
- **4.3** Interested buyers shall sign a yearly agreement with BALCO for utilization and consumption of ash (Dry Fly ash, bottom ash, and pond ash) in environment friendly manner as per the prevailing guidelines of MOEF &CC, and SPCB.
- **4.4** Interested buyers will bear the cost of transportation of ash in an environment friendly manner for utilization / consumption as per their requirement at their risk and cost.
- **4.5** All the costs for transportation and utilization, necessary regulatory permissions, taxes, duties etc. as applicable will be in the scope of the prospective buyer.
- **4.6** Ash (Dry Fly ash, bottom ash, and pond ash) to be loaded will be made available by VL as per the quantity mentioned in the agreement.
- **4.7** Mode of packing, loading, transportation, and utilization must be clearly mentioned by the interested buyer.
- **4.8** Interested buyers may clearly indicate the inputs required from BALCO.
- **4.9** All the works of ash packing, loading, and transportation must be executed confirming to the EHS rules and regulations of BALCO.

5.0 Required Information:

5.1 As per MoEF & CC notification, Prospective buyers are required to submit the copy of valid CTO issued by CPCB/CPSB/SPCB for consumption of ash in manufacturing of ash-based products from ash and use of ash in construction / other ash-based Product / industry

/ road construction / land filling / export to other sites to participate in e auction process.

- **5.2** The prospective buyers are required to submit particulars of the firm with the background of operation, business where ash will be utilized, tentative plan, and proposed quantity of fly ash to be utilized etc.
- **5.3** The buyer submitting the EOI shall be bearing all costs associated with the preparation and submission of the EOI and BALCO will, in no case be responsible or liable for these costs, regardless of the conduct or outcome of the assessment/evaluation process.
